THIS DEED OF TRUST made on this 21st day of January, 1994 by S. Gurbachan Singh s/o Late S. Darshan Singh resident of 5-A, New Vijay Nagar, Jalandhar, Author and Founder of the trust, named as SAHIBZADA AJIT SINGH EDUCATIONAL TRUST, herein-after called as the TRUST at Jalandhar.

NOW THIS TRUST DEED WITNESSESS AS UNDER:--

1. The name of the trust shall be 'SAHIBZADA AJIT SINGH EDUCATIONAL TRUST'.

2. PROPERTY OF THE TRUST:

That the author S. Gurbachan Singh the settler being absolute owner hereby unconditionally settled land measuring 9Kanal 2 Marlas vide Khasra No. 75, 6/2, 7, Jamabandi 1987-88 Khatta No. 457 dated 27.11.92 No. 472 Intkal No. 6952 situated at

Khatta No. 1178/1863 of Jamabandi 1987-88 No. 264 Intkal No. 6929 dt. 24.7.1992 at Dhilwan Distt. Kapurthala as property of The Trust. The trust may accept, receive donations, endowments gifts, in cash or in kind in the form of land, building, stock, shares, securities & debentures) or any other moveable and immoveable property for the trust.

3. OFFICE.

That the Registered office of the Trust shall be located at Ist Floor, 191, SCO Gujral Nagar, Jalandhar and activities of the Trust shall be carried on there or such other place in or outside the State of Panjab as Trust may deem fit.

4. AIMS AND OBJECTS

That the aims and objects of the Trust for which it is established and which shall extend to the whole State of Panjab shall be as under:-

- a) The basic object of the Trust is to impart extensive education to the needy by maintaining and managing:-
 - i) DHILWAN INTERNATIONAL PUBLIC SCHOOL, DHILWAN.
- b) To open other schools and colleges.
- c) To make other provisions for imparting education in Arts Science and any other subject.

and to make regulations relating to residence and conduct of student s studying and residing in the institutions maintained an managed by the Trust.

- e) To Patronize, encourage and grant stipends to poor and deserving students for higher education and specialized study in Science or technical subjects.
- f) To construct building, Laboratories, Hostels. Workshops, residential houses and acquire property(immovable and moveable) for the fulfilment of the aims and object of the Trust in India.
- g) To print publish books and litrature.
- h) To do all such other things and deeds and to take all steps, which are incidentials and conducive to this attainment of the above aims and objects of the trust.

5. COMPOSITION OF THE TRUST;

That the trust shall constitute maximum nine Trustees and minimum five trustees. The founder of the Trust shall be the Life Time President of the Trust and after his death his wife Smt. Jaswinder Kaur shall be the Life time president of the trust after her death his son S. Tarwinder Singh shall be the Life Time President of the Trust or next of his kin shall be life time President of the trust. The trust shall have office bearer, Preside Secretary. 6. APPOINTMENT/ REMOVAL OF TRUSTEES AND OFFICE BEARER OF THE TRUST.

The appointment of the new trustee or appointment on account of vacancies caused by resignation in capabilities, removal or death of any trustee or appointment of any office bearer of trust or supernation or removal of any of the trustee or office beaere or change in the designation of any of the office bearer shall be made by passing a resolution by 2/3 majority of the total member of the

The president's consent is necessary for any appointment, suspension or removal. The trustee can be removed if he becomes unsound mind declared insolvent or convicted by the court for Moral offence or acts against the aims and object of the Trust,

7. MEETING OF THE TRUST.

The meeting of the trust shall be convened by the Secretary of the Trust and shall be presided by the president. The quorum of the meeting shall not be less than 3 members. The Register of the meeting of the Trust and all other relevant records shall be in the custody of the Secretary. The president or secretary shall call special meeting when any of them is requested in writing by at least 1/3 members of the trust. The president can direct the Secretary at any time to call the meeting. In case of the fractional vote the President shall have the right of casting vote. All resolution shall be pass by simple majority except those are provided otherwise under the trust deed or rules framed thereunder:

8. DISPOSAL OF IMMOVABLE TRUST PROPERTY.

The trust may transfer ~~sell~~ Sell, exchange, mortgage immovable property of the trust when it is necessary for the best interest of the trust by passing a resolution by 2/3 majority of the total members on the board of the Trust or after obtaining written consent from the 2/3 members provided that President of the trust must agreed to it. Any amount of money received on account of the sale of such property shall be capital of the trust.

9. Maintenance of accounts.

The trust shall maintain proper income and expenditure account for the each financial year. The trust money beyond the extent needed for the urgency shall be kept in the Bank account of the Trust. The Bank account or accounts of the trust shall be operated by the President. The accounts of the trust shall be audited every year by Chartered Accountants duly appointed by the Trust.

10. APPOINTMENT OF THE ADVISORY COMMITTEE.

The trust shall appoint an advisory committee for giving advice to the trust in day to day working of the trust. The advice of the advisory committee shall not be binding upon the trust. The trust advisory committee shall consist of maximum fifteen members, The members of the Advisory committee shall be appointed by the president. The function of the advisory committee shall be provided under the rules and regulation of the Trust.

11. RULES AND REGULATION

The trust shall frame the rules and regulations for the smooth

The rules and regulations can be ammended from time to time by 2/3rd majority of total members of the trust or by taking consent in writing of 2/3rd members of the trust provide that consent of the President is necessary for any ammendment.
